4. Application Agreement

- 1.) After sending this application form we have to do a formal check with members of the Expert Council.
- 2.) In case of a positive result your application fee is to pay and the expert council will decide about your participation based on the artist and gallery information you sent us. Attention! All applications are considered by the Expert Council. After the Expert Council decision Art Moscow could reject your application.
- 3.) After the confirmation of your participation, the participant has to pay 100% of the first invoice (space, registration-advertisement and electrical fee) until April 3 to the organizer. Accepted applications will be countersigned and dated by Art Moscow Representative to become a binding contract.
- 4.) The full prepayment for the exhibition including all the additional services must be done upon final invoice before one month to the fair. The cooperative advertisement fee is 500€ for each page in the fair catalogue. Minimal two obligatory pages are requested. An application fee of 500€ and a fee for electrical supply 145€ are obligatory too.
- 5.) The organizer has the right to cancel the application and to change the location of the booth if the payments are not in time. If the Exhibitor fails to make the payments, Art Moscow has the right to reassign the exhibitors booth.
- 6.) If after April 3 2009, the exhibitor inform the organizer that he will be not participating, then has the organizer the right not to return the deposit which was transferred by the participant.
- 7.) No application will be processed without the required deposit amount. Please remit the obligatory application fee of 500€ with this application. In case of a not acceptance by the Expert Council, the fee will be repaid less charges of 150€ . All payments have to be remitted in Euro € . Banker's commission must be charged from remitters account.
